BSRLM Treasurer AGM report 2021

Overall summary

The BSRLM's current overall balance is £26,748.17, suggesting a second year of greater stability in our overall finances. However, patterns of income and expenditure continue to be impacted by the Covid-19 pandemic.

The continuation of online conferences has continued to support attendance of a geographically wide delegate base and this has meant that membership subscription has increased for the second successive year. The continuation of online operation means also that no committee expenses have been incurred. Both of these factors have contributed to the stability of the overall balance this year.

Website costs have increased; this is partly accounted for in the payment of the second and final fee for the redevelopment of the website. However, on going costs have also increased as we now pay a £144 monthly fee to the White Fuse platform which hosts our new site as well as the approx. £280 monthly ongoing maintenance costs of the site.

The payment of membership subscriptions by either direct debit or repeat card payment continues to work efficiently. Our web platform no longer supports the use of Paypal and thus the Paypal account has been closed. Existing members paying by standing order to the bank account will receive an email shortly inviting a switch to direct debit which is administratively simpler and more efficient.

The temporary suspension of the payment of a grant to cover the expenses of RME has been ended and a grant that will hopefully cover the running costs for 2021-22 has been transferred to the RME account. This will be monitored and more added if needed.

The current situation, whilst currently appearing stable, may change when in person conferences return; discussions at last year's' AGM regarding a slow overall decline in the overall balance may need to be revisited but with the significant reserve in our savings account these discussions can perhaps be put on hold for now. The opt out of receipt of paper copies of RME discussed last year has been agreed and a mechanism for those who wish to take this option is under discussion.
