BSRLM Executive Annual report template

The BSRLM's current overall balance is £30,660.23, suggesting an increase in comparison to the previous year in our overall finances. It is the first year after the pandemic outbreak we had on-site conference (June 2022).

The on-site conference brought back committee expenses, Janet Duffin award expenses and support for New Researchers through the Leone Burton fund. Regardless the increase in the expenses, the income from the conference fees and the increase from the RME royalties contributed to an overall increase of approximately 15% in the overall balance this year.

Website costs is a substantial part of our expenditures, currently the monthly cost is approximately £155 monthly fee to the White Fuse platform which hosts our new site as well as the approximately £240 monthly ongoing maintenance costs of the site.

The payment of membership subscriptions by either direct debit or repeat card payment continues to work efficiently. Existing members paying by standing order to the bank account will receive a reminder by email shortly inviting a switch to direct debit which is administratively simpler and more efficient.

The cost of RME printed copies has declined in comparison to the previous year (approximately 24%). The opt out of receipt of paper copies of RME has been agreed and a mechanism for those who wish to take this option is set up on the website.

After the switch to the online banking some of the practices in BSRLM became redundant (e.g., cash payments, check books, paper-based authorisation of payments, etc.). At the same time the risk for fraudulent cyberattacks has increased. The Co-operative Bank and the two platforms (GoCardless and Stripe) that support membership and conference payment keep increasing the security protocols with the aim to keep exchanges safe. As a response to the increase risk described above, the BSRLM executive introduced a protocol of verification and security controls for finances that is summarised in the following actions:

- A verification process for payments in now in place (each new payment is verified either by two executive members or by the entire executive committee.
- Two auditors will be appointed for two years.
- Bank accounts are monitored monthly, and any unusual transaction is reported.

• Regular checks on security processes at the website and payment platforms will be followed.

Please find the accounts set down for Nov 2021 – Oct 2022. The working on these accounts has been checked by Nancy Barclay, November 2022.
